A. Rental of Storage Unit

- Micah attended and completed the Cross Connection Certification class and has earned the certification. The Certification is renewed every three years.
- The Bloomington Normal Water Reclamation District (BNWRD) project which is referred to as the "Meadows Interceptor" is being engineered by Baxter Woodman. A draft proposal for the design is tentatively scheduled for early July. The engineering firm was asked to incorporate a possible BTPWD water main placement in the design. Kevin Hanel of Farnsworth Group (BTPWD's engineer) is being kept in the loop.
- Kevin Hanel (engineer) is still working on the long-range planning for BTPWD.
