Previous Minutes Approval:

Manager's Report

A. General Updates

- Semi-annual flushing has been completed for 2024.
- Continuing to flush in Crestwicke to keep chlorine residual levels adequate. He
 has talked to the City of Bloomington, they are providing higher chlorine at the
 meter but downstream in the system the levels are decreasing.
- Non-revenue water usage West Phase is holding steady, Crestwicke has dropped significantly.
- Disinfection by product testing (done twice a year) was delivered to the lab in November.
- Attended ILRWA training in Peoria the main focus of that seminar was nitrification action plans.
- Meters are still on backorder however 24 meters are being transferred from another store and will be made available to BTPWD.
- There has been notification by J.U.L.I.E. that there will be changes in the law regarding locates effective January 1, 2025. He will have more information as it becomes available.
- He is arranging meetings with Kevin Hanel from Farnsworth and with Scadaware regarding upgrades.
- Noted that there has been some information about the City of Bloomington and their water supply regarding meeting water demand in the future with concerns about the reduction of capacity in their lake supply.

Attorney Report

Treasurer Williams explained that there was a customer with an outstanding balance from July and that she had sent the final bill, followed up with an email one month later and a month after that sent a formal letter on BTPWD letterhead. Then she

turned it over to attorney Joe Dehn for his input and follow up. She noted as of the November meeting – payment had not been received.

Joe explained that his letter was sent on BTPWD letterhead as the attorney for BTPWD. Since payment has not been received – he will send another letter on his law firms' letterhead, noting that legal action will be taken.
